The PBG for the due performance and fulfilment of the agreement should be valid for 3 months after completion of the work under the particular work order

6. Clause 8.6 page 24 (**Period of Empanelment**)

The following is added to this clause:

NeGD shall give the Bidder at least a notice of 90 days if the empanelment is decided to be curtailed for no reason.

7. Clause 8.8 (b) page 25 (**Termination / Withdrawal**)

"If the agency does not execute the contract to the satisfaction of the NeGD then" should be read as:

"If the agency does not execute the contract as per the scope of the work then"

8. This corrigendum forms an integral part of the tender document.

9. All other terms and conditions remain the same.
