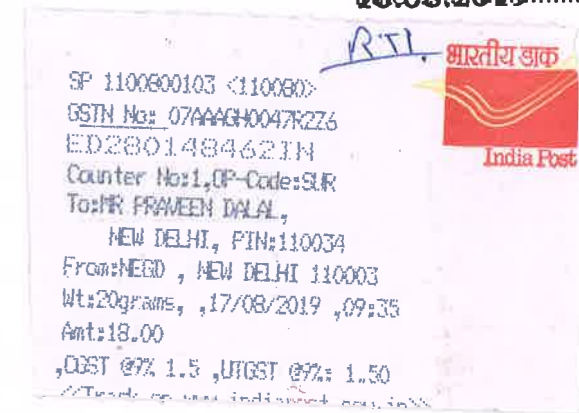

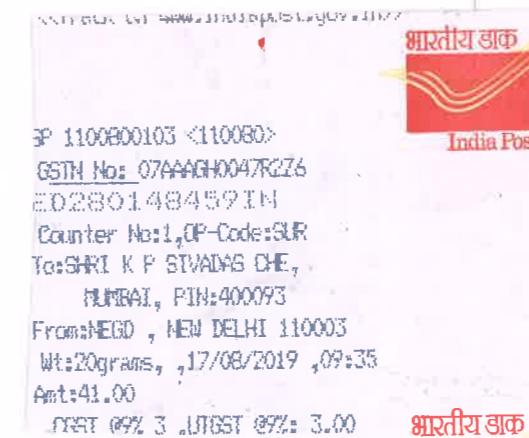

All the guests whomsoever were invited to record the sessions were either high level officials from State/Central Ministries, or representatives from Public/Private banks and NPCI (national Payment Corporation of India). Their TA/DA was taken care by their respective Departments/Ministries/Institutes/Banks.
