By capturing real-world experiences and lessons, the Casebook aims to strengthen responsible AI adoption and accelerate digital transformation in healthcare systems.

Researchers, innovators, and institutions from across the Global South are invited to submit **abstracts (maximum 250 words)** capturing successful, implementable, scalable AI in health use cases by **31st October 2025**. Selected contributors shortlisted based on relevance, quality, and alignment with the Casebook's goals will be invited to submit full chapters (2,500–3,000 words) detailing the AI solution, deployment strategy, ethical considerations, impact achieved, and lessons learned.
